(e) Rainwater harvesting facility should be installed. (f) Plan (PPA) Approval of the school building should be furnished to the Inspecting Officer concerned, within a period of one year, without fail. (g) The Fee structure of the said school should be displayed in the Notice Board of the school. (a) The salary and the D.A., should be paid to the teaching and non-teaching staff, as per the Labour Dept., G.O.Ms. No.40/LAB/AIL/G/2013 dt.18.10.2013. (h) School Disaster Management Plan (SDMP) and School Safety Disaster Awareness Training Programme should be conducted, as per the instructions contained in the Circular No.7318 dt.09.03.2018, issued by the Joint Director (S.E), Directorate of School Education, Puducherry.		

2. The management of the said school is informed that all the conditions as stipulated in the ANNEXURE to this Certificate and those prescribed in the Pondicherry School Education Rules, 1996 should be fulfilled failing which further continuance of recognition is liable to be rejected.
